C. GRADING AND DRAINAGE

Driveways and parking areas shall be graded and provided with adequate drainage to dispose of surface waters in accordance with applicable construction and design standards. Surface water shall not drain on to adjoining lots, towards buildings or across a public street, except in accordance with an approved drainage plan.

Proposed construction plans will also be reviewed by Village Engineer and DPW Supervisor.
