Chief Neymanowski stated that unfair statements were said about his authority. Introduced Bruce Meyers as the Lone Ranger. Chief stated that those on horses and living in Oxford would like to represent the village and endorse this group as a mounted division from the village.

Kennis commented to get clarification on the use of village uniforms by the horse unit. Was concerned on the horses and possible injuries to people attending village functions.

Dolan questioned Chief on the matter.

Helmuth commented on the value of the Chief to the Village.

Callie Meyers, stated the allegations are not all correct. Gave copies of documents to the council.

Bruce Meyers, addressed the council on newspaper articles and the uniforms the horse riders were wearing.

Motion by Bossardet and second by Kennis the village attorney that the Village Attorney immediately initiate notices, letters and communications making it clear that the Oxford Village Council has not reviewed, approved, authorized, sanctioned or otherwise allowed an Oxford Village Mounted Police Division, reserve or otherwise, in the Village of Oxford. The persons involved should be notified to cease any and all activities wherein there is a representation of any kind that they are part of the Village of Oxford Police Department in any way. By example only, the Motion requires a legal communication to the Michigan Multi-Jurisdictional Mounted Division respectfully making it clear that these three (3) individuals do not represent the Village of Oxford in any way and are not associated with the Village of Oxford in any way. Further, all uniforms, patches, equipment or any other items provided to these individuals by the Village of Oxford shall be immediately retrieved. Also, and as a core component of this Motion, I am asking that the Village Manager and Police Chief cooperate fully in this regard and that neither take any additional actions to promote any affiliation between these individuals and the Village of Oxford. Nothing in this Motion prevents this issue from being presented to this Village Council at a future meeting wherein the Village Council has an opportunity to review, prior to a meeting, all of the issues and potentially act accordingly.

Bailey stated motion is broad and requested changes to the motion, and seconded the amended wording.

- 14. Council Comments: Kennis very proud of the equestrian team and their efforts in supporting the village. Council has to make an unpopular decision due to the fact the council was not well informed and the process was mismanaged. Helmuth stated that City of Fraser dumping sewage in the Clinton River has made her very upset, along with how the Police Chief issue was handled. DPW had the park looking beautiful for Christmas and cleared the roads today with the snow. Chief acted very professional when being questioned in an open meeting. Bailey stated there are negative attitudes toward government, and agrees with Helmuth in what happened tonight, did not like the conduct of the council. Dolan stated that perception of government is negative. Council has been given poor, erroneous or incomplete information, it is necessary to do things correctly. Bossardet also appreciated the DPW for moving the printing press. Asked on the progress on a single grease hauler for the community. Thanked Dolan for bringing the bond issue forward. The issue was not on the equestrian team.
